### VI. PUBLIC HEARING:

A. Public Hearing regarding proposed rezoning of the property located at the Southwest corner of Tara Boulevard and North Avenue, Jonesboro, GA 30236, land lot 239, 13<sup>th</sup> district 0.579 acres Parcel #: 13239BD005. The current zoning of such property in Clayton County is GB (General Business District) and Tara Boulevard Corridor Overlay District and the proposed municipal rezoning is C2 (Highway Commercial District) and Tara Boulevard Overlay District.
